#### 10. Course Aims:

The overarching aims of the stage 2 electives are as follows:

- Encourage interdisciplinary, critical reflexivity from within an open set of choices;
- Foster deep investigative approaches to new or unfamiliar areas of practice and theory;
- Cultivate self-directed leadership and initiative-taking in both applied and abstract modes of practice/ study not necessarily associated with a student's particular creative specialism;
- Enable flexible, ethical exploration and connection of diverse knowledge and understanding within a specialist programme of study.

Central to this course is the use of drawing techniques and practices to explore, document and understand our surroundings as a context for practice. The course also considers the prominence of the city within contemporary creative practice.

#### 11. Intended Learning Outcomes of Course:

By the end of the course students should be able to:

- Use a range of mapping and drawing techniques as analytical, descriptive and problem-solving tools;
- Understand the use of such techniques within a variety of contemporary and historic creative practices;
- Understand the use of such techniques in relation to their own discipline;
- Organise and conduct a project using these techniques effectively.

#### 12. Indicative Content:

The course introduces a variety of techniques available to artists, designers and architects for conceptualizing, analyzing and delineating their surroundings, and the use of the city as a location for exploration and discussion.
