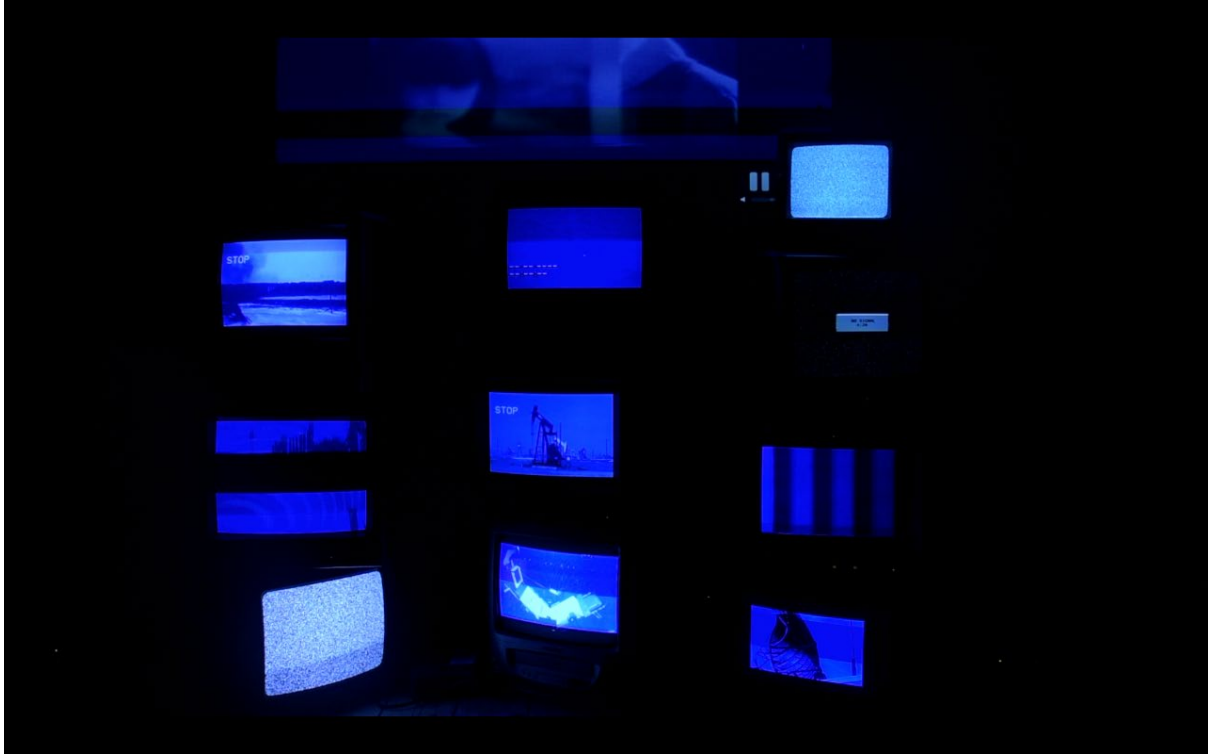

### Course Introduction

This course focuses on the development of increasingly sophisticated forms of creativity using audio/audio-visual technology, the execution of a high-quality original output that demonstrates the students' professional expertise through making and critical writing, and the development of a heightened sense of professional identity in students.

Students are supported through building a portfolio that explores who they are as a practitioner, directed to employers, collaborators and institutions within the student's desired creative fields. Students can exercise their practical skills and their values; those found both internally on creative fields and in the broader social space, past present and future.

### Course Aims

The course aims to

- Enable students to critically understand their creative practice and future career by conceptualising their agency within the traditions and conventions of their chosen creative field.
- Support students to create, discuss and critically improve a conceptually complex practical project, and encourage students to constructively critique each other's work.
- Prepare students to communicate their work to specialist and non-specialist audiences, considering the societal and/or environmental positioning and impact of their work

### Course Intended Learning Outcomes

By the end of this course students will be able to:

- Apply and justify the use of professional tools and workflows I for a chosen field, with appropriate audio/audio-visual production and post-production processes Design and develop a self-directed work (audio-only, or audio-visual) that communicates an original concept informed by a chosen research theme.
- Critically reflect on and analyse individual practice through discussion and examination of key historical and contemporary theory on the chosen field of practice.
- Communicate project outcomes, concepts and processes in a structured and accessible manner to diverse audiences.

### Indicative Content

Student projects will likely scatter amongst diverse fields of practice/industries so it would not be appropriate to teach domain-specific technical lectures for this project. Instead, lecture content will be relevant for all students covering:

- philosophy of creativity agency and decision making
- sociology of creative fields – makers, domain, audience
- industry/community practical guidance in navigating institutional protocols around making work for a public audience (such as risk assessment, ethics, health and safety)

### Description of Learning and Teaching Methods

There will be lectures covering commonly applicable themes (see above). In addition to lectures, students will be offered:

- Interactive guided group discussions
- Preparatory self-directed learning activities (using interactive learning technologies such as Padlet), set to enhance the depth of discussions in class, and scaffold the learning process, to motivate the students along this extended self-directed project conceptualisation and production.

Student work is primarily developed through self-directed study and development, supported by regular group reviews of work in progress in interactive lab sessions.

Course tutors and Teaching Assistants are additionally available to provide critical commentary and analysis of student work in progress.

### Description of Formative Assessment and Feedback Methods

Students are supported in their learning through a range of formative assessment activities as they progress through the course. These include:

- Engagement in peer review workshops/presentations
- In-class discussion and question and answer activities
- Written or verbal feedback on work in progress
- Formal review point half-way through the course

### Description of Summative Assessment arrangements

This Course has two summative assessment components:

#### Practical output

Students will submit a practical output (or documentation of a live practical output) in the form of a video / audio file, and a Critical Reflection and Statement document (1500 words total, not including references).

#### Critical Reflection & Statement (1500 words)

The critical reflection and statement should present a suitable conceptual analysis, using appropriate specialist terminology and academic references. The included statement will be in the form of a short text (200-300 words) written for the public audience explaining the practical work in accessible language.

Submissions will be assessed and moderated in line with the Code of Assessment. Students are awarded an aggregate grade based on the weighted grade of the two components. Reassessment opportunities where a student has not passed the course are outlined in the Code of Assessment.
