#### **Course Introduction**

'Practice as Research' enables students to understand and articulate how their practice can be a process of investigation shared with others. Engaging with debates concerning the relationship of practice and research, the course introduces methods by which knowledge and insight can be gained and shared from the interaction of artistic practice with the world. The course also outlines ways in which knowledge and understand are socially and politically constructed and ways in which artistic practice can decentre and decolonise established canons and orthodoxies. A key objective is to promote innovative, experimental, and ambitious work that relates to academic study and creative practice at the forefront of the field of contemporary art and related disciplines.

#### **Course Aims**

The course aims to:

- Introduce new ways of thinking about artistic practice as enquiry through engagement with a range of different research methods.
- Enable you to design and plan development of your research project or practice grounded in appropriate research methods relevant.
- Develop critical analysis and evaluation of appropriate research methods and methodologies.
- Support your rigorous understanding and application of ethics as relevant to your research and practice.
- Enable to the development of in-depth understanding and knowledge of how to undertake research within independent arts practice and study

## **Course Intended Learning Outcomes**

Upon full participation in and successful completion of the course, you will be able to:

- Critically evaluate and apply various research methods appropriate to contemporary art practice, demonstrating originality in using enquiry-based approaches.
- Design and plan a practice-led artistic research project, showing self-direction in identifying, selecting, and justifying appropriate methodological approaches.
- Understand the potential relevance and impact of practice-led artistic research to wider social, cultural, and other fields and audiences as relevant.
- Apply ethical principles with rigour and insight, evidencing awareness of professional, social, and cultural responsibilities within contemporary art research and practice.

#### **Indicative Content**

Lectures introduce core research strategies, present a range of research methods and methodologies, and explore key themes and debates surrounding Artistic Research. Students are encouraged to critically engage with these concerns as they begin to develop appropriate methods and methodologies for their own research project / object / practice. The second half of the course introduces group and one-to-one sessions where students test their methodologies for practice and gain critical feedback from staff and peers.

## **Description of Learning and Teaching Methods**

Lectures, case studies and group work facilitate critical reflection on the relationships between forms of research and modes of practice to support a robust and innovative applications of existing methods. The course delivers to all SoFA PGT programmes and offers opportunities for cross-programme engagement and activity. A series of core lectures is followed by student-led presentations and group tutorial support.
